I have agreed to Volunteer my services to the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council. In consideration of the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council accepting me as a Volunteer, I represent and agree to the following:

A. GENERAL PROVISIONS

1. I will attend any required orientation meeting(s) and will complete any required training program(s) for my Volunteer position.
2. As a Volunteer, I am not considered as an employee of the Baltimore County Department of Recreation and Parks, Baltimore County or the Lake Roland Nature Council and I will not receive compensation for my services.
3. I will operate within the scope of duties for my Volunteer position, shall abide by all the rules and regulations of the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council, and shall abide by all directions and instructions given by its personnel.
4. As a representative of the Nature Council I will do my best to be courteous and helpful to those I encounter in Lake Roland during my Volunteer activities. As a representative of the Nature Council, Volunteers should be working in partnership with the Nature Council and Baltimore County, not in opposition to these organizations. This partnership includes the adherence to all Baltimore County and State of Maryland Laws by the Volunteer.
5. I will review any handbooks or other written materials provided by the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council relating to my Volunteer facility and position.
6. I am not authorized to enforce the rules and regulations of Baltimore County.
7. Transportation to and from any Baltimore County property, facility or event is my own responsibility. While enroute to or from such property, facility or event I am acting on my own and am not acting on behalf of the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council, its officers, Directors, Commissioners, employees or agents.
8. I may be required, based on the scope and role of my Volunteer activities for the Nature Council, to submit to an annual background check to be performed by the Baltimore County Department of Recreation and Parks. Lake Roland Nature Council Volunteers who participate in activities involving children and Board Members and Committee Members (collectively referred to as Volunteers) are required by Baltimore County to undergo an annual background check. Only Volunteers that have a background check and who are listed by Baltimore County as having had and passed such may participate in an event involving children.

B. LIABILITY WAIVER

The undersigned, for myself and my heirs and executors, successors, and assigns, hereby releases and discharges the Baltimore County Department of Recreation and Parks and the Lake Roland Nature Council, its Officers, Directors, Commissioners, employees or agents, Volunteers and servants of a2nd from any and all claims, demands and causes of action whatsoever nature which I or my heirs and executors, successors, and assigns ever may have against any of them for, on account of, by reason of, or arising in connection with the aforesaid Volunteer Program and my services as a Volunteer therein and hereby waive any and all such claims, demands and causes of action.
