This Agreement sets forth the terms and conditions under which the Lake Roland Nature Council (LRNC) will install and maintain a commemorative recycling station funded by \_\_\_\_\_ (“Donor”), and is effective \_\_\_\_\_, 20\_\_.

1. Donor agrees to provide LRNC the sum of \$3,750 (Three thousand seven hundred and fifty dollars) upon Donor’s return of a signed and fully executed Agreement along Recycling Station with a check or money order payable to Lake Roland Nature Council. The donation of the Recycling Station will also include the cost of a 10” x 5” plaque with text designated by Donor and approved by LRNC. The lettering is sand cast and raised from the brown leather background. Bronze lettering in Palatino font, maximum 50 characters, no more than 4 lines.
2. The Recycling Station subject to this agreement is located at the place indicated on the attached map. The type of Recycling Station (standard park design).
3. LRNC agrees to purchase and install the Recycling Station. If the Recycling Station or plaque is damaged or stolen, LRNC will repair or replace it at no additional cost to the Donor.
4. Donor shall acquire no right, title, or interest in the Recycling Station and plaque beyond that expressly identified in this Agreement. Donor acknowledges and understands the Recycling Station will be open and available for general public use in a manner consistent with Lake Roland and Baltimore County policies and practices.
5. Any dispute regarding this Agreement or the operation of the Recycling Station Donation Program will be resolved at the sole discretion of the Executive Committee of the LRNC. Any other appeal or complaint process, whether in court or otherwise, is expressly waived by Donor.
6. Donor expressly agrees that except as set forth in writing in this Agreement, there are no other obligations or duties on the part on part of the LRNC or Baltimore County with respect to the subject of the Recycling Station or plaque.
